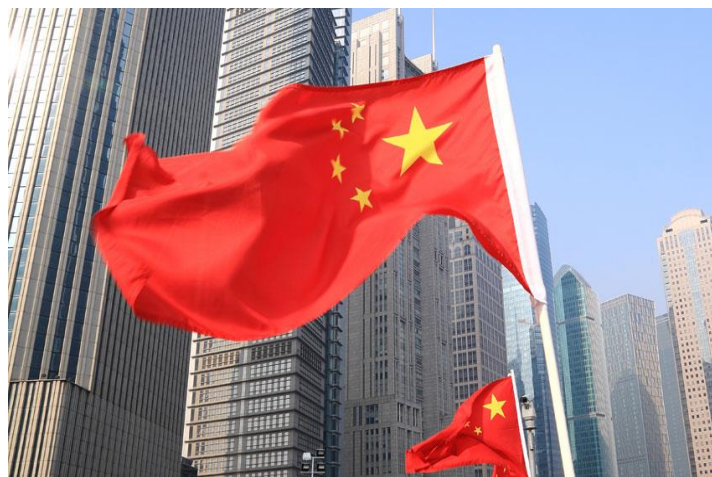
### **Why the GGI Deserves Praise**
